Naj npawb 1 yog lub npe, chaw nyob thiab xov tooj rau lub tsev tshuaj uas tau ntim cov tshuaj rau hauv lub hwj no. Lub hwj tshuaj no yog lub "Tsev Tshuaj Main Street" muab.

Naj npawb 2 yog tus kws kho mob lub npe. Kws Kho Mob R. Wilson tau sau daim ntawv yuav yam tshuaj no.

Naj npawb 3 yog tus naj npawb rau lub hwj tshuaj, nws pib nrog cov tsiaj ntawv "Rx" los sis "No". Tus naj npawb rau lub hwj tshuaj no yog 300443.

Naj npawb 4 yog tus neeg mob lub npe. Yam tshuaj no yog rau John Johnson. Lwm tus neeg yuav tsum tsis txhob noj yam tshuaj no.

Naj npawb 5 qhia seb yuav tau no tshuaj ntau npaum li cas thiab yuav tsum noj thaum twg. Tej zaum yuav sau li no tom qab lo lus "Dose". John yuav tsum noj 1 lub tshuaj ib hnub ib zaug.

Naj npawb 6 yog lub npe rau yam tshuaj no, thiab lub npe ntawm lub tsev lag luam uas tau ua cov tshuaj no. Yam tshuaj no hu ua "Zocor," thiab Merck yog lub tsev lag luam uas tau ua cov tshuaj no.

Naj npawb 9 qhia seb daim ntawv sau yuav tshuaj tas kas nuv rau hnuv twg. Tej zaum yuav sau li no tom qab lo lus "refill before" uas txhais tau hais tias "rov qab mus nqa ua ntej," los sis tom qab cov tsiaj ntawv "Exp." Nov yog hnuv kawg uas lub tsev tshuaj yuav muab tau cov tshuaj ntxiv.
